

## Summary of changes to TACP and TADP 2024

### Tennis Anti-Corruption Program 2024

TACP Section	Change effective 01 January 2024 (in red)
B.30	Deleted in entirety as PTIOs no longer exist, and duties undertaken by the ITIA Rules Committee.
B.31 (now B.30)	<p>“Related Person” refers to any coach, <del>PTIO</del>, trainer, therapist, physician, management representative, agent, family member, tournament guest, business associate or other affiliate or associate of any Player, or any other person who receives accreditation at an Event at the request of the Player or any other Related Person.</p> <p>A person shall be a Related Person for the purposes of this Program, and shall remain bound by all provisions of this Program, until two years after the last Event at which the Related Person receives accreditation unless the Related Person:</p> <ul style="list-style-type: none"> <li>(i) <del>Notify</del> <u>Notifies</u> the appropriate Governing Body in writing that they are no longer receiving accreditation in which case they will cease to be a Related Person on the date of that notice <u>(unless any of (ii), (iii) or (iv) below apply);</u>–</li> <li>(ii) <u>Serves in a non-playing capacity on a team at a team Event, in which case the Related Person shall remain bound by all provisions of this Program for one year after the last team Event at which the Related Person served in such capacity (unless a longer period applies under another section of this Section B.30);</u></li> <li>(iii) <u>Is subject to a period of ineligibility under this Program or the TADP, in which case the covered period shall cease upon the conclusion of two years or such period of ineligibility (whichever is the later) (unless (iv) applies as at such date);</u> or</li> <li>(iv) <u>Is aware that they are the subject of an ITIA investigation and/or a law enforcement investigation<sup>2</sup>, in which case the covered period shall instead cease upon the ITIA closing the investigation or the Related Person or ITIA being informed that the law enforcement investigation has been closed, or ten years, whichever is earlier (unless (iii) applies as at such date).</u></li> </ul>

G.2.f	<p>Where B.302(i)(vi) applies, the ITIA shall, where possible, notify the person that they remain a Related Person by reason of such investigation (save where it is not aware of a law enforcement investigation into the Related Person or has not been authorized to notify the Related Person by law enforcement) and shall notify them when they are no longer a Related Person.</p> <p>Deleted “the PTIOs” and replaced with “<u>members of the ITIA Rules Committee (or their nominee(s))</u>”</p>
B.39. (now B.38)	<p>“Tournament Support Personnel” refers to any tournament director, official, owner, operator, employee, agent, contractor <u>(save for in-house tournament broadcast contractors<sup>1</sup> and contractors/staff in food service, cleaning, maintenance and vendor roles and any other role which has a minimal player/official facing or match-related element and is not privy to any non-public player information)</u> or any similarly situated person and ATP, ITF, GSB and WTA staff providing services at any Event and any other person who receives accreditation at an Event at the request of Tournament Support Personnel...</p> <p><u><sup>1</sup> This term is intended to cover broadcast personnel who are contracted by the tournament in circumstances where the tournament produces its own broadcast feed and where such personnel solely perform roles which would otherwise have been delivered by an external broadcaster. It does not include contractors/staff who perform support services for the tournament’s broadcast function (e.g. security personnel or drivers, unless they fall within another exception in this Section).</u></p>
D.1.k	<p>No Covered Person shall, directly or indirectly, offer, pay or accept any money, benefit or Consideration for the provision of a wildcard to an Event.<sup>1</sup></p> <p><u><sup>1</sup> Actions by a Covered Person which are taken not for personal financial gain but solely pursuant to a commercial agreement(s) of an Event which is permitted under the relevant Governing Body’s rules are not prohibited under this Section D.1.k.</u></p>
D.1.p	<p>No Covered Person shall <del>sell, purchase, collect, publish or, while on site at an Event, make repeated</del> transmissions of <del>or otherwise disseminate</del> the contemporaneous results of any aspect of any Event <u>for the purpose of Tennis Betting</u> without the consent of <del>anythe relevant</del> Governing Body or Event <del>either on site at an Event (“Courtsiding”) or remotely during an Event by scraping or scouting information from websites, data streams or other electronic sources of live scoring data.</del></p>

TADP Section	Change effective 01 January 2024 (in red)
10.14.3	Where an Event that will <u>or may</u> take place after the period of Ineligibility has an entry deadline that falls during the period of Ineligibility, the Player may submit an application for entry in the Event in accordance with that deadline, notwithstanding that at the time of such application they are still Ineligible.
10.13.2.1	Any period of Provisional Suspension (whether imposed or voluntarily accepted) that has been respected by the Player or other Person will be credited against the total period of Ineligibility to be served. <u>If a period of Ineligibility is served pursuant to a decision that is subsequently appealed, then the Player or other Person shall receive a credit for such period of Ineligibility served against any period of Ineligibility which may ultimately be imposed on appeal.</u>
